1. Introduction

Fuss & O'Neill was retained by Sandwich Public Schools (the "Client") to conduct a six-month periodic surveillance of previously-identified asbestos-containing building materials (ACBM) at the following schools:

- 1. Henry T. Wing School
- 2. Sandwich High School

This periodic surveillance was conducted in accordance with the requirements of the United States Environmental Protection Agency (EPA) Asbestos Hazard Emergency Response Act (AHERA) (Title 40 CFR, Part 763, Subpart E).

On July 15, 2021, Mr. Robert Mallett of Fuss & O'Neill performed the periodic surveillance. This surveillance was based on available information in the existing Asbestos Management Plan (AMP) for each school.

2. Scope of Work

Periodic surveillance involves the visual re-assessment of any ACBM or assumed ACBM as identified in the AMPs prepared for Sandwich Public Schools. The date of the periodic surveillance, as well as the location of each area, was noted along with any changes in ACBM condition. The results of this surveillance are listed in the periodic surveillance forms included in this report.

3. Discussion

During this periodic surveillance, no changes in conditions were observed to the ACBM identified in the AMPs. Specific ACBM locations and conditions are listed in the attached periodic surveillance forms for each school.

AHERA regulations pertain to interior identified or assumed ACBM and limited exterior ACBM. AHERA regulations do include ACBM located on exterior porticos, covered walkways, and mechanical equipment used to condition interior building air.

4. Conclusion

No changes in conditions for previously identified ACBM were observed compared with the most recent AMPs.

If renovation or demolition activities are scheduled that will impact identified ACBM, the ACBM must be removed by a Commonwealth of Massachusetts-licensed Asbestos Contractor prior to disturbance. This is a requirement of the Commonwealth of Massachusetts Department of Labor Standards (MADLS) as well as EPA NESHAP.
